TPSODL has made this service available to you as a matter of convenience. TPSODL expressly disclaims any claim or liability arising out of the provision of this service. You agree and acknowledge that you shall be solely responsible for your conduct and that TPSODL reserves the right to terminate your rights to use the service immediately.
